

GEORGE W. McGLOTHLEN TO T. S. McGLOTHLEN

THIS INDENTURE, MADE THE 3RD DAY OF OCTOBER, IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FOUR BETWEEN GEORGE W. McGLOTHLEN, THE PARTY OF THE FIRST PART, AND T. S. McGLOTHLEN, THE PARTY OF THE SECOND PART, WITNESSETH: THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE (1) DOLLARS, LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD, REMISED, RELEASED AND FOREVER QUIT-CLAIMED UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED PROPERTY AND MINING PROPERTY, LOCATED IN SKAMANIA COUNTY, IN THE (STATE OF ) OF WASHINGTON, DESCRIBED AS FOLLOWS TO-WIT:

THE UNDIVIDED ONE-HALF INTEREST IN THAT CERTAIN MINING CLAIM KNOWN AS THE BADGER QUARTZ MINING CLAIM, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT DISCOVERY ON THE ORIGINAL LOCATION; THENCE ABOUT 300 FEET NORTH (WEST VARIATION 10°) TO NORTHWEST CENTER END; THENCE RUNNING 1500 FEET SOUTHEASTERLY WITH 300 FEET ON EACH SIDE OF THE CENTER LEAD; ALL CORNERS MARKED AND CENTER LINE BLAZED; IN NIGGER HEAD MINING DISTRICT; NOTICE OF LOCATION RECORDED IN BOOK "F", PAGE 159 RECORDS OF SKAMANIA COUNTY, WASHINGTON; JOINS JUMBO QUARTZ CLAIM ON THE EAST SIDE LINE OF JUMBO; ALSO BOB WHITE ON THE NORTH END, AND BEAVER CLAIM ON THE SOUTH END OF THE BADGER QUARTZ CLAIM; TOGETHER WITH ALL THE DIPS, SPURS, AND ANGLES, AND ALSO ALL THE METALS, ORES, GOLD AND SILVER BEARING QUARTZ-ROCK AND EARTH THEREIN; AND ALL THE RIGHTS, PRIVILEGES AND FRANCHISES THERETO INCIDENT, APPENDANT AND APPURTENANT OR THEREWITH USUALLY HAD AND ENJOYED; AND ALSO, ALL AND SINGULAR THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, AND THE RENTS, ISSUES AND PROFITS THEREOF; AND ALSO, ALL THE ESTATE, RIGHT, TITLE, INTEREST, PROPERTY, POSSESSION, CLAIM AND DEMAND WHATSOEVER, AS WELL IN LAW AS IN EQUITY, OF THE SAID PARTY OF THE FIRST PART, OF, IN OR TO THE SAID PREMISES, AND EVERY PART AND PARCEL THEREOF, WITH THE APPURTENANCES.

TO HAVE AND TO HOLD, ALL AND SINGULAR, THE SAID PREMISES, TOGETHER WITH THE APPURTENANCES AND PRIVILEGES THEREUNTO INCIDENT, UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS FOREVER.
