THOUSAND NINE HUNDRED AND TWENTY-FOUR. BETWEEN T. S. MCGLOTHLEN, THE PARTY OF THE
FIRST PART, AND GEORGE W. MCGLOTHLEN, THE PARTY OF THE SECOND PART, WITNESSETH:
THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE
(\$1.00) DOLLARS, LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID
BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED,
HAS GRANTED, BARGAINED, SOLD, REMISED, RELEASED AND FOREVER QUIT-CLAIMED UNTO THE
SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS, THE FOLLOWING DE-
SCRIBED PROPERTY AND MINING PROPERTY, LOCATED IN SKAMANIA COUNTY, IN THE (STATE OF)
OF WASHINGTON, DESCRIBED AS FOLLOWS TO-WIT:
