SECOND PART, HIS HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY, SITUATE,  
LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

ALL OF GOVERNMENT LOTS 3, 4 AND 9 OF SECTION 25 TOWNSHIP 3 NORTH OF RANGE  
7½ EAST OF W.M., EXCEPTING THAT PORTION OF LOT 3 LYING NORTHERLY FROM IVETOT ROAD
