THIS AGREEMENT, MADE AND ENTERED INTO BY AND BETWEEN W. S. WILLIAMS, PARTY OF THE FIRST PART AND ELLEN WILLIAMS PARTY OF THE SECOND PART, BOTH OF STEVENSON, WASHINGTON, SKAMANIA COUNTY, WITNESSETH, THAT,

WHEREAS, THE PARTIES HERETO ARE HUSBAND AND WIFE, AND ARE THE OWNERS OF REAL AND PERSONAL PROPERTY WITHIN THE STATE OF WASHINGTON, ALL OF SAID PROPERTY, WHETHER STANDING OF RECORD IN THE NAME OF ONE OR BOTH PARTIES, IS COMMUNITY PROPERTY, AND

WHEREAS, THE SAID PARTIES DESIRE TO ESTABLISH THE STATUS OF ALL COMMUNITY PROPERTY NOW OWNED BY THEM, OR WHICH MAY HEREAFTER BE ACQUIRED BY THEM, AND TO MUTUALLY AGREE AS TO THE DISPOSITION OF THE WHOLE OF SAID PROPERTY UPON THE DEATH OF EITHER IN THE MANNER PROVIDED BY SECTION 6894 REMINGTONS COMPILED STATUTE 1922,
