

(E) ALL OF THE INCOMES, REVENUES, CONTRIBUTIONS, RECEIPTS, ELECTRIC AND OTHER RENTS, CONTRACTS(PARTICULARLY INCLUDING CONTRACTS WITH MUNICIPALITIES, INDIVIDUALS AND CORPORATIONS WITH RESPECT TO THE SUPPLYING TO SUCH MUNICIPALITIES, INDIVIDUALS AND CORPORATIONS OF ELECTRICITY FOR DISTRIBUTION TO PRIVATE CONSUMERS OR FOR ANY OTHER PURPOSE AND/OR CONTRACTS FOR THE USE BY THE PARTY OF THE FIRST PART OF POLES, WIRES AND/OR TRANSMISSION LINES BELONGING TO OTHERS THAN THE PARTY OF THE FIRST PART), LEASES, CLAIMS, ACCOUNTS, DEMANDS, CHOSES IN ACTION, BONDS, SHARES OF STOCK AND OTHER SECURITIES, BOOKS OF ACCOUNT AND CONTRACT RIGHTS OF ALL KINDS BELONGING TO THE PARTY OF THE FIRST PART, EXPRESSLY INCLUDING GOOD WILL, AND ALL STORES, REPAIR PARTS, STOCK IN TRADE, MATERIALS AND SUPPLIES, AND ALL OTHER PROPERTY, RIGHTS, PRIVILEGES, FRANCHISES, LICENSES, EASEMENTS AND PERMITS OF ANY AND EVERY KIND AND DESCRIPTION, REAL, PERSONAL AND MIXED, NOW OWNED BY THE PARTY OF THE FIRST PART WHERESOEVER THE SAME MAY BE SITUATED AND NOT HEREINBEFORE SPECIFIED OR REFERRED TO, WITH THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANY WISE APPERTAINING, AND THE REVERSION AND REVERSIONS, REMAINDER AND REMAINDERS THEREOF.
