WITNESSETH, That the SAID PARTIES OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF FIVE HUNDRED FLETY-SEVEN AND 20/100 DOLLARS (\$557.20), TO THEM IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO BY THESE PRESENTS GRANT, BARGAIN, SELL, REMISE, RELEASE AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HIS HEIRS AND ASSIGNS FOREVER, ALL THE FOLLOWING DESCRIBED LOTS, PIECES OR PARCELS OF LAND SITUATE IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON, AND KNOWN AND DESCRIBED AS FOLLOWS, TO-WIT:

That part of the South half of the Southeast quarter of the Southeast quarter ($S^{\frac{1}{2}}$ of $SE^{\frac{1}{4}}$ of Section Nineteen (19) in Township Three (3), Range Eight (8), E. W.M., which lies Northeasterly of a creek running across said land, comprising about One and One-third acres, more or less.

The North Half of the Southeast quarter of the Southeast quarter ($N\frac{1}{2}$ of $SE\frac{1}{4}$) of said Section Nineteen (19) in Township Three (3), Range Eight (8), E.
