SCHEDULE A.

The property referred to in the granting clause in the foregoing Indenture from West Coast Telephone Company to Bank of America National Trust and Savings Association, a National Banking Association, and W. J. Kieferdorf, Trustees, dated March 1, 1939, includes parts or parcels of real property and other property hereinafter more specifically described. Such description, however, is not intended to limit or impair the scope of intention of the general description contained in the granting clauses or elsewhere in said Indenture and is not to be construed as a limitation of the provisions of said Indenture subjecting to the lien thereof all property now owned or hereafter acquired by said West Coast Telephone Company.

I. REAL ESTATE.

A. Properties in Clark County, Washington.

(a) That portion of Lots 5 and 6, Block 38, Town of La Camas according to plat thereof recorded in volume "B" of plats, page 25, records of said County, more particularly described as follows: Beginning at the northeasterly corner of said block 38 at the intersection of the southerly line of northeast Fifth Avenue and the westerly line of Northeast Cedar Street; thence westerly on the southerly line of Northeast Fifth Avenue, 90 feet; thence south parallel to the westerly line of Northeast Cedar Street, 50 feet; thence easterly parallel to the southerly line of Northeast Fifth Avenue 90 feet to the westerly line of Northeast Cedar Street; thence northerly along the westerly line of Northeast Cedar Street, 50 feet to the point of beginning; Also all right, title and interest of West Coast Telephone Company, a corporation, under that certain party wall agreement recorded in Book 180 on pages 22 and 23, Records of Deeds for Clark County, Washington, and appurtenant to above land, but subject to any leasehold interest outstanding on any of the above described property;

(b) Beginning at a point one hundred sixty (160) feet South of the Southwest corner of Block Four (4) of Surbers Addition to Washougal City, as per the duly recorded plat thereof of record in the office of Auditor of Clark County, Washington. Thence East fifty (50) feet; thence South twenty-five (25) feet; thence West fifty (50) feet; thence North twenty-five (25) feet to the place of beginning.

B. Properties in Island County, Washington.

(a) Beginning at the Southeast corner of Lot numbered 1 in Block numbered 18 in Alexander's Plat of Glenwood, according to the original plat thereof on file and of record in the office of the County Auditor of Island County, State of Washington, and running thence North 15 feet; thence West 50 feet; thence South 15 feet; and thence East 50 feet to the point of beginning, in the Town of Coupeville, Washington.

(b) Lot numbered 2 in Block 18 of the aforesaid Plat of Glenwood, excepting the East 60 feet of said Lot 2.

C. Properties in Grays Harbor County, Washington.

(a) Lot Thirteen (13), Block One (1) of Byles' and Dabney's Addition to C. N. Byles' Plat in Montesano.

(b) The West 26 feet of Lot Six (6) in Block Three (3) of C. N. Byles' Plat of Montesano, subject to party wall rights in the East Wall of the building upon
