KNOW ALL MEN BY THESE PRESENTS, THAT W. H. MILLER AND MARY A. MILLER HIS WIFE, OF KLUCKITAT COUNTY, WASHINGTON, AND PETER AHOLA AND E. M. AHOLA, HIS WIFE, OF THE COUNTY OF SKAMANIA, IN THE STATE OF WASHINGTON, IN CONSIDERATION OF THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF EIGHTEEN HUNDRED DOLLARS, IN HAND PAID, RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE OF WASHINGTON, THE FOLLOWING DESCRIBED PARCEL OF LAND SITUATED IN SKAMANIA COUNTY, WASHINGTON, TO-WIT:

A STRIP OF LAND 100 FEET WIDE, EXCEPT AS NOTED BEING 50 FEET ON EACH SIDE OF THE CENTER LINE OF SAID ROAD EXCEPT AS NOTED AS SURVEYED OVER AND ACROSS A STRIP OF LAND IN LOTS 2, 3 & 4 OF SECTION 31, TWP. 3 N. R. 8 E. W.M., HAVING WIDTHS AS HEREINAFTER SET FORTH ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINES OF STATE ROAD No. 8 (NORTH BANK HIGHWAY) IN SKAMANIA COUNTY, WASHINGTON, AS NOW LOCATED AND OF RECORD IN THE OFFICE OF THE STATE HIGHWAY ENGINEER AT OLYMPIA, WASHINGTON, TO-WIT:

BEGINNING AT A POINT ON THE WESTERLY BOUNDARY LINE OF SAID SECTION 31, WHICH BEARS S. 0° 08' W., A DISTANCE OF 127.1 FEET FROM THE $\frac{1}{4}$ CORNER ON THE WEST SIDE OF SAID SECTION 31, TWP. 3 N. R. 8 E. W.M., THENCE N. 60° 44' E., 72.3 FEET, HAVING A WIDTH OF 50' ON THE NORTH SIDE AND 100 FEET ON THE SOUTH SIDE; THENCE CONTINUING N. 60° 44' E., 150.0 FEET, HAVING A WIDTH OF 60 FEET ON THE NORTH SIDE AND 100 FEET ON THE SOUTH SIDE; THENCE CONTINUING N. 60° 44' E., 1673.5 FEET, HAVING A WIDTH OF 50 FEET ON EACH SIDE; THENCE ON THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 358.1 FEET A DISTANCE OF 259.6 FEET, HAVING A WIDTH OF 50.0 FEET ON EACH SIDE; THENCE N. 19° 12' E., 116.9 FEET, HAVING A WIDTH OF 50.0 FEET ON EACH SIDE; THENCE CONTINUING N. 19° 12' E., 76.4 FEET, HAVING A WIDTH OF 50.0 FEET ON THE WEST SIDE AND 75.0 FEET ON THE EAST SIDE; THENCE ON THE ARC OF A CURVE TO THE RIGHT, HAVING A RADIUS OF 143.2 FEET A DISTANCE OF 123.6 FEET, HAVING A WIDTH OF 50.0 FEET ON THE NORTH SIDE
