THIS INDENTURE, MADE THE 21ST DAY OF JANUARY, A.D. 1926. IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-SIX, BETWEEN HENRY BLANKENSHIP, THE PARTY OF THE FIRST PART, AND SKAMANIA MINING ASSOCIATION, AND CRESCENT MINING ASSOCIATION, THE PARTIES OF THE SECOND PART, WITNESSETH: THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TWENTY-ONE DOLLARS, LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY THE SAID PARTIES OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD, REMISED, RELEASED, AND FOREVER QUIT-CLAIMED, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL, REMISE, RELEASE, AND FOREVER QUIT-CLAIM UNTO THE SAID PARTIES OF THE SECOND PART, AND TO THEIR SUCCESSORS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL ESTATE AND MINING PROPERTY, LOCATED IN THE NIGGERHEAD MINING DISTRICT OF SKAMANIA COUNTY, STATE OF WASHINGTON, ALL AND SINGULAR THE MINING LOCATIONS^{HOLDINGS} AND CLAIMS OF THE SAID PARTIES OF THE SECOND PART IN SAID DISTRICT AND COUNTY; WITH ALL AND SINGULAR THE CLAIM OR CLAIMS OF THE FIRST PARTY THERETO, OR TO ANY PART THEREOF; TOGETHER WITH ALL THE DIPS, SPURS, AND ANGLES, AND ALSO ALL THE METALS, ORES, GOLD AND SILVER BEARING QUARTZ-ROCK AND EARTH THEREIN; AND ALL THE RIGHTS, PRIVILEGES, AND FRANCHISES THERETO INCIDENT, APPENDANT AND APPURTENANT^{OR THERewith} USUALLY HAD AND ENJOYED; AND ALSO, ALL AND SINGULAR THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING OR IN ANYWISE APPERTAINING, AND THE RENTS, ISSUES AND PROFITS THEREOF; AND, ALSO, ALL THE ESTATE, RIGHT, TITLE, INTEREST, PROPERTY, POSSESSION, CLAIM, AND DEMAND WHATSOEVER, AS WELL IN LAW AS IN EQUITY, OF THE SAID PARTY OF THE FIRST PART, OF, IN, OR TO THE SAID PREMISES, AND EVERY PART AND PARCEL THEREOF, WITH THE APPURTENANCES

TO HAVE AND TO HOLD ALL AND SINGULAR, THE SAID PREMISES, TOGETHER WITH THE APPURTENANCES AND PRIVILEGES THEREUNTO INCIDENT, UNTO THE SAID PARTIES OF THE SECOND PART, THEIR SUCCESSORS AND ASSIGNS FOREVER.
