Whereas, as of the first day of July, 1928, West Coast Telephone Company, a Washington corporation, presently having its principal place of business in Everett, Washington, made, executed and delivered a Trust Indenture or Bond Mortgage to The United States National Bank of Portland (Oregon), Corporate Trustee, and C. L. LeSourd, Seattle, Washington, Individual Trustee, as Trustees, authorizing and securing the issue of said West Coast TelephoneCompany's First Mortgage Gold Bonds in an unlimited face amount of bonds, and under which Trust Indenture said West Coast Telephone Company has issued First and Refunding Mortgage Five Per cent Gold Bonds, Series A, and First and Refunding Mortgage Five Per cent Gold Bonds, Series A, and First and Refunding Mortgage Five Per cent Gold Bonds, Series B, and which Trust Indenture was recorded in various counties in the States of Oregon and Washington; and as to the County of Skamania, State of Washington, recorded July 5, 1928, in book S, page 266, mortgage records, and filed as a schattel mortgage on the same date under file number 14941; and

Whereas, West Coast Telephone Company has duly and legally called for payment, in accordance with the terms of said Trust Indenture, all bonds issued under said Trust Indenture and now outstanding, and has deposited with the corporate trustee the principal sum required for the payment of all of said bonds so outstanding, and called for payment, together with interest accrued to date of payment, and premiums, as provided in said Trust Indenture, and in the bonds secured thereby, and all other sums payable under said Trust Indenture by West Coast Telephone Company, including all lawful charges and disbursements then unpaid;

Now, Therefore, in consideration of the payment in full of the indebtedness secured by said Trust Indenture and the sum of ten dollars (\$10) lawful money of the United States of America to them paid by said West Coast Telephone Company, the receipt of which is hereby acknowledged, and of the observance and performance of all covenants and conditions required in said Trust Indenture to be kept, performed and observed by said West Coast Telephone Company, the undersigned, The United States National Bank of Portland (Oregon), Corporate Trustee, and C. L. LeSourd, Seattle Washington, Individual Trustee, do hereby acknowledge the satisfaction of said Trust Indenture or Bond Mortgage, and do hereby GRANT, RE-ASSIGN, RECONVEY, TRANSFER, RELEASE and DELIVER unto WestCoast Telephone Company, its successors and assigns, without any warranty, all and singular, the property, rights, privileges and franchises granted, conveyed and assigned under said Trust Indenture and not previously disposed of as therein provided, except cash deposited with the undersigned, The United States National Bank of Portland (Oregon), Corporate Trustee, for the payment of the indebtedness secured by said Trust Indenture, as herein-before set forth.
