THE PETITION OF ANDREW RASMUSSEN OF THE CITY OF PORTLAND, STATE OF OREGON,
RESPECTFULLY SHOWS:

THAT CAROLINA GRAGERSON RASMUSSEN DIES ON OR ABOUT THE 3RD DAY OF MARCH,
A.D. 1917, AT PORTLAND, OREGON.

THAT SAID DECEASED AT THE TIME OF HER DEATH WAS AN INHABITANT OF THE
COUNTY OF MULTNOMAH IN SAID STATE OF OREGON, AND LEFT ESTATE IN THIS COUNTY CON-
SISTING OF REAL PROPERTY.

THAT THE PROBABLE VALUE AND CHARACTER OF THE SAID PROPERTY IS AS FOLLOWS,
TO-WIT:

UNDIVIDED ONE-HALF OF LOTS ONE AND TWO IN BLOCK 34 A. L. MINORS ADDITION,
COUNTY OF MULTNOMAH, STATE OF OREGON.

UNDIVIDED ONE-HALF OF LOTS 9, 10, 11, 12, 13, 14, 15 AND 16 IN BLOCK 72
IN ROSEDALES SUBDIVISION TO ASTORIA, CLATSOP COUNTY AND STATE OF OREGON.

UNDIVIDED ONE-HALF OF A TRACT OF LAND BEGINNING 15 RODS SOUTH OF THE
NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION TWENTY-EIGHT TOWNSHIP TWO NORTH
