MORTGAGE

THE MORTGAGOR, Josephine Blied, a widow, in consideration of the sum of \$767.80, in hand paid, receipt whereof is hereby acknowledged, does by these presents mortgage unto Laurence M. Jones all of the following described real property situated in the County of Skamania, State of Washington, to-wit:

The Northeast Quarter of the Southeast Quarter of Section Ten (1), Township One (1) North, Range Five (5) East, of the Willamette Meridian, containing Forty (40) acres, more or less, according to the government survey thereof.

This mortgage is given to secure the payment of one certain promissory note, of which the following is substantially a copy, to-wit:

Vancouver, Washington March 4, 1937

On or before five years after date, for value received, I promise to pay to the order of Laurence M. Jones, the sum of Seven Hundred Sixty-seven and 80/100 (\$767.80) Dollars, with interest thereon at the rate of 6% per annum from date until paid, interest payable quarterly, and if not so paid, the whole sum shall become immediately due and collectible at the option of the holder hereof. If not so collected, the interest shall be added to the principal and shall bear like interest therewith until paid, and in case suit or action is instituted to collect this note or to foreclose the mortgage securing the same, I further agree to pay such additional sum as the court may adjudge reasonable as attorneys' fees.

The mortgagor further agrees to pay all taxes and assessments against the said real property promptly before the same become delinquent, and not to commit or suffer strip or waste of the premises.
