CONLEY, OF THE COUNTY OF MULTNOMAH, STATE OF OREGON, HAS BARGAINED AND SOLD, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID JAMES L. CONLEY, HIS HEIRS AND ASSIGNS, ALL THE FOLLOWING BOUNDED AND DESCRIBED REAL AND PERSONAL PROPERTY, SITUATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

TOWNSHIP TWO (2) NORTH, RANGE SIX (6) EAST:

SECTION ONE (1). ALL THE TIMBER ON LOTS ONE (1) AND TWO (2) AND THE SOUTH HALF OF THE NORTHEAST QUARTER ( $S\frac{1}{2}$  OF  $NE\frac{1}{4}$ ) WITH RIGHT TO ENTER UPON THE LAND AND REMOVE THE TIMBER AT ANY TIME WITHIN TWENTY-FIVE YEARS FROM APRIL 10, 1903. LOTS THREE (3) AND FOUR (4), AND THE SOUTH HALF OF THE NORTHWEST QUARTER ( $S\frac{1}{2}$  OF  $NW\frac{1}{4}$ ) AND THE NORTH HALF OF THE SOUTH HALF ( $N\frac{1}{2}$  OF  $S\frac{1}{2}$ ) SUBJECT TO MINERAL RESERVATIONS AND RESERVATION OF RIGHT TO CARRY ON MINING OPERATIONS, ALSO RIGHT OF WAY FORTY (40) FEET WIDE RESERVED ACROSS THE LAND FOR A LOGGING ROAD.

SECTION TWENTY-NINE (29). THE NORTHEAST QUARTER ( $NE\frac{1}{4}$ ), THE WEST HALF ( $W\frac{1}{2}$ ), THE WEST HALF OF THE SOUTHEAST QUARTER ( $W\frac{1}{2}$  OF  $SE\frac{1}{4}$ ), AND THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER ( $SE\frac{1}{4}$  OF  $SE\frac{1}{4}$ ).
