Know all Men by these Presents, That Whereas Northwestern Electric Company (hereinafter called the Company), a corporation of the State of Washington, with its principal executive office in the City of Portland, Oregon, executed and delivered its Trust Indenture dated as of May 1, 1915 to Harris Trust and Savings Bank, a corporation of the State of Illinois, with its principal place of business in the City of Chicago, Illinois, and to Howard W. Fenton, of the City of Chicago, State of Illinois, as Trustees, to secure the payment of the principal of and interest upon its First Mortgage Twenty Year Sinking Fund Gold Bonds issued and outstanding under said Trust Indenture, and thereby conveyed to said Trustees, upon the trusts, terms and conditions, and subject to the provisions and covenants contained in said Trust Indenture, all and singular the property whether real or personal, then owned by the Company, and also all and singular the property which should be thereafter acquired by the Company, under which Trust Indenture all bonds issued and outstanding as of June 30, 1939, (exclusive of bonds in the principal amount of \$3,185,100 held in Sinking Fund of the Company) aggregate the principal amount of \$5,371,900; which Trust Indenture was filed and recorded in the office of the County Clerk of Multnomah County, Oregon, and in the offices of the respective Auditors or county recording officers in and for each of the hereinafter mentioned counties in the State of Washington on the following dates, and is now recorded, indexed and on file in the records of said offices, as follows:
