Whereas the Company, on January 25, 1935, submitted a proposal to the holders of its First Mortgage Twenty Year Sinking Fund Gold Bonds for the extension of the maturity of said Bonds to May 1, 1945, and on June 17, 1935, submitted a proposed Extension Agreement to the District Court of the United States for the District of Oregon as a plan of reorganization pursuant to the provisions of Section 77B of the Bankruptcy Act of the United States, as amended; and said court on July 22, 1935, entered its Order confirming said Extension Agreement as a plan of reorganization with certain modifications, and on May 11, 1936, entered its final decree discharging the Company as debtor and closing the proceedings; and said Order of Confirmation and said Final Decree provided and directed, respectively, among other things, that certified copies thereof should be filed for record in each of the counties of the States of Oregon and Washington, wherein the properties covered by said Trust Indenture were situated; and the Company pursuant to said Order and Decree caused certified copies of each thereof to be filed and recorded in the office of the County Clerk of Multnomah County, Oregon, and in the offices of the respective Auditors or county recording officers in and for each of the hereinafter mentioned counties in the State of Washington on the following dates, and said Order and Decree are now recorded, indexed, and on file in the records of said offices as follows:
