Skamania County, Washington, on February 17, 1937, in Book "U" of Mortgages, at page 34, and filed on the same date in the Chattel Mortgage Records as Auditor's Chattel Mortgage file No. 23,718;

Clark County, Washington, on February 17, 1937, in Volume 247 of Mortgages, at page 377, and filed on the same date in the Chattel Mortgage record as Auditor's Chattel Mortgage file No. D-69324.

Whereas Harold Eckhart, of Evanston, Illinois, formerly of the Village of Winnetka, Illinois, has been substituted as, and is now, successor to Howard W. Fenton, as Co-Trustee, under said Trust Indenture; and instruments with respect to the substitution of said Harold Eckhart, as Co-Trustee, as aforesaid, were filed and recorded in the office of the County Clerk of Multnomah County, Oregon, and in the offices of the respective Auditors or county recording officers in and for the counties of Cowlitz, Klickitat, Skamania and Clark, in the State of Washington, and are now recorded, indexed and on file in the records of said offices; and

Whereas the Company has fully provided for the redemption of all of the bonds and coupons, as so extended, secured by said Trust Indenture as so supplemented and modified, and has deposited cash (or surrendered in lieu thereof bonds and coupons which have been cancelled) with the Trustee in the entire amount necessary for such redemption and has paid all sums accruing and payable under said Trust Indenture by the Company; and

Whereas the Company has requested the cancellation, satisfaction and discharge of the lien of said Trust Indenture, Order of Confirmation, Final Decree, and Supplemental Indenture, and the execution and delivery to it of such deeds and instruments as shall be requisite to satisfy of record the lien thereof and reconvey and transfer to the Company the mortgaged and pledged property;

Now, Therefore, said Harris Trust and Savings Bank and said Harold Eckhart (as successor to said Howard W. Fenton), as Trustees, in consideration of the premises and One Dollar to them in hand paid by the Company, receipt of which is hereby acknowledged, do hereby cancel and discharge the lien of said Trust Indenture, dated as of May 1, 1915, said Order of Confirmation entered on July 22, 1935, said Final Decree entered on May 11, 1936, and said Supplemental Indenture dated as of December 1, 1936, and do hereby acknowledge that the Company has fully provided for the redemption of all of the bonds and coupons, as so extended, issued under and secured by said Trust Indenture and has deposited cash with the Trustee in the entire amount necessary for such redemption and has paid all sums accrued and payable thereunder by the Company; and said Trustees do hereby acknowledge that said Trust Indenture, Order of Confirmation, Final Decree and Supplemental Indenture and all indebtedness secured thereby are accordingly fully satisfied and discharged;

Said Trustees do hereby authorize and direct the County Clerk of Multnomah County, Oregon, and the respective County Auditors or other recording officers in each county in the States of Washington in which said Trust Indenture, Order of confirmation, Final
