COMMENCING AT THE SE CORNER OF BLOCK 8 OF THE TOWN OF STEVENSON, THENCE S 55° 30' W 266.5 FEET, THENCE N 25° W 148.5 TO THE POINT OF BEGINNING OF TRACT TO BE CONVEYED; THENCE N 25° W 80 FEET MORE OR LESS TO THE SOUTH LINE OF THE PROPERTY COMMONLY KNOWN AS THE "GILLETTE PROPERTY"; THENCE WEST 65.5 FEET TO THE WEST LINE OF THE HENRY SHEPARD D.L.C.; THENCE ^{SOUTH} /ALONG THE WEST LINE OF THE SAID HENRY SHEPARD D.L.C. 90 FEET; THENCE IN A NORTHEASTERLY DIRECTION TO THE POINT OF BEGINNING.

3. COMMENCING AT THE NORTHWEST CORNER OF TRACT No 1 ABOVE DESCRIBED, THENCE NORTH ALONG THE WEST LINE OF THE HENRY SHEPARD D.L.C. TO THE SOUTHWEST CORNER OF TRACT No 2 ABOVE DESCRIBED, THENCE IN A NORTHEASTERLY DIRECTION ALONG THE SOUTH LINE OF SAID TRACT No 2 TO A POINT WHICH IS 10 FEET DUE EAST OF THE WEST LINE OF THE SAID HENRY SHEPARD D.L.C., THENCE SOUTH TO INTERSECTION WITH THE NORTHEASTERLY LINE OF TRACT No 1; THENCE N 25° W TO THE POINT OF BEGINNING, BEING A STRIP OF LAND 10 FEET IN WIDTH ALONG THE WEST LINE OF THE SAID HENRY SHEPARD D.L.C., CONNECTING THE TWO PARCELS OF LAND ABOVE DESCRIBED.

4. BEGINNING AT THE NE CORNER OF TRACT No. 2 ABOVE; THENCE S. 25° E 44 FT; THENCE IN A NORTHERLY DIRECTION TO INTERSECTION WITH THE SOUTH LINE OF THE ABOVE MENTIONED "GILLETTE" PROPERTY AT A POINT 14½ FEET E OF THE POINT OF BEGINNING; THENCE W 14½ FEET TO POINT OF BEGINNING.
