G. C. Grenia et ux to Bank of Stevenson.

THIS INDENTURE, Made this 18th day of December in the year of our Lord one thousand nine hundred and thirty nine BETWEEN G. C. Grenia and Lura A. Grenia, his wife parties of the first part, and Bank of Stevenson a Washington corporation party of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Three hundred and no/100 DOLLARS, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged do by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its successors heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and the State of Washington, and particularly bounded and described as follows, to-wit:

Commencing at the intersection of the center line of Strawberry road with the center line of State Highway No 8 in sec 36 tp 3 N R 7 1/2 E W.M., thence northerly along the center line of Strawberry road 257 feet for point of beginning; thence northerly along the center line of Strawberry road to the south line of Stevenson Park Addition, thence east to center of Vallett Creek, thence following the center line of Vallet creek in a southeasterly direction to intersection with the center line of State Road No 8, thence following the center line of State Road No 8 in a southerly direction to a point 356 feet distant from the intersection with Strawberry road (measured from said point of intersection with Strawberry road easterly along the center line of State Road No 8), thence in a straight line in a westerly direction to the point of beginning, containing three acres more or less.

(Note--Road and State Highway references are to be the same as located and established March 16th 1925).
