(g) Also all materials and supplies (exclusive of merchandise held for resale), appertaining to and held, owned and claimed by West Coast Power Company in said county for use in connection with and as a part of said electric distribution system in said county.

(h) Also all automotive equipment or tools, and all office equipment situated in said County of Skamania for use in connection with and as a part of said electric distribution system in said county.

(i) Also all accounts receivable arising out of sales of electric energy and generally described as "accounts receivable electric" belonging to West Coast Power Company and arising out of retail sales of electric energy in said county,

(j) Also all special service contracts to governmental agencies and other customers at special rates.

(k) Also that certain overhead cable with its towers, guys and other appurtenances now in place across the Columbia River, as more particularly described in that certain permit issued to Columbia River Light & Power Company by the Secretary of War on June 16, 1921, the termini of which are situated in Hood River County, Oregon, and Skamania County, Washington, respectively.

And generally, without limitation of the foregoing language, all of the used and useful properties and assets belonging to West Coast Power Company and situated in Skamania County, Washington (except as hereinbefore otherwise stated) and used or kept for use by said Company for the distribution and sale of electric energy to the public in said county.

TO HAVE AND TO HOLD the property aforesaid unto said West Coast Power Company, its successors and assigns forever.

This release is made without covenant or warranty, express or implied, on the part of said The Chase National Bank of the City of New York and said Carl E. Buckley and shall in no way affect or impair the right of the said The Chase National Bank of the City of New York and said Carl E. Buckley to hold under said Indenture of Mortgage, dated as of January 1, 1936, as security for the sum remaining due thereon or to sell under the power of sale contained in said Indenture of Mortgage, dated as of January 1, 1936, or to foreclose as therein set forth or in any other lawful manner, all the remainder of the property therein conveyed and not hereby or heretofore released.
