

WASHINGTON, TO-WIT:

A STRIP OF LAND ONE ROD IN WIDTH ALONG THE WEST SIDE OF THE NE $\frac{1}{4}$ OF THE NW $\frac{1}{4}$ OF SECTION 28 Twp. 3 N. R. 8 E. W.M. ALSO ON, OVER AND ACROSS THE FOLLOWING DESCRIBED TRIANGULAR STRIP OF LAND AS AN APPROACH THEREWITH, TO-WIT: COMMENCING AT THE SW CORNER OF THE ABOVE DESCRIBED ROD STRIP OF LAND BEING AT THE NW CORNER OF THE SE $\frac{1}{4}$ OF THE NW $\frac{1}{4}$ OF SEC. 28 AFORESAID THENCE S 20 FEET, THENCE NORTHEASTERLY TO A POINT ONE ROD EAST OF THE INITIAL POINT OF THE ABOVE TRIANGULAR TRACT THENCE WEST TO THE PLACE OF BEGINNING.

IT BEING THE INTENT HEREBY THAT THE PARTIES HERETO SHALL AND MAY HAVE THE RIGHT, USE AND ENJOYMENT OF THE ABOVE DESCRIBED STRIP OF LAND FOR ROAD PURPOSES FOR THE USE AND BENEFIT OF THE LAND NOW OWNED BY THE SAID PARTIES FOR WHICH SAID ROAD SERVES AS AN OUTLET TO THE COUNTY HIGHWAY AND FOR THE PURPOSE OF MAINTAINING SUCH LIGHT, POWER AND OTHER UTILITIES AS MAY NOT INTERFERE WITH THE USE THEREOF FOR ROAD PURPOSES.
