That Whereas, on the 2nd day of May, 1938, M. W. Beck and Charlotte Ann Beck, husband and wife, being then the owners of those certain premises situated in the County of Skamania and State of Washington as follows:

All that tract or parcel of land the northeast corner of which is situated at a point 30 feet west of the northeast corner of Lot Nine (9), Section One (1), Tp.
