This Indenture, between Catharine Wright and R. M. Wright, wife and husband, parties
of the first part and Bank of Stevenson, a corporation, party of the second part, WITNESSETH:

Whereas, by inadvertence description contained in that certain mortgage dated January
5, 1940 and filed for record January 5, 1940, in the office of the Auditor of Skamania
County, Washington under Auditor's File No. 28307 is erroneous.

Therefore it is agreed, between the parties hereto that the real property mortgaged
