ORDER OF SOLVENCY.

THE ABOVE ENTITLED MATTER COMING ON TO BE HEARD, THIS 9TH DAY OF AUGUST, 1924, FOR THIS ORDER, UPON THE PETITION AND REPORT OF NELLIE HERMANN, EXECUTRIX OF THE ESTATE OF ERNEST HERMANN, ABOVE NAMED DECEASED, AND IT APPEARING TO THE COURT THAT THE APPRAISERS APPOINTED BY THE COURT HAVE APPRAISED SAID ESTATE AND FILED AN INVENTORY OF ALL THE PROPERTY OF SAID ESTATE; AND THE COURT UPON EXAMINING SAID INVENTORY AND BEING FULLY INFORMED CONCERNING ALL MATTERS CONNECTED HERewith FINDS THAT SAID ESTATE IS FULLY SOLVENT; THAT DUE NOTICE TO CREDITORS IS BEING PUBLISHED AS PROVIDED FOR BY LAW; THAT THE WILL OF SAID DECEASED, WHICH HAS BEEN ADMITTED TO PROBATE IN THIS COURT IS A NON-INTERVENTION WILL AND GIVES THE EXECUTRIX FULL POWER AND AUTHORITY TO SETTLE SAID ESTATE WITHOUT THE FURTHER INTERVENTION OF THIS COURT; THAT THE SAID EXECUTRIX HAS QUALIFIED AS SUCH EXECUTRIX AND IS ACTING AS SUCH, NOW THEREFORE,

IT IS ORDERED THAT THE REQUEST OF SAID EXECUTRIX TO BE ALLOWED TO MANAGE AND SETTLE SAID ESTATE WITHOUT THE FURTHER INTERVENTION OF THE COURT BE AND THE SAME IS HEREBY ALLOWED, IN THE MANNER PROVIDED FOR IN SAID WILL OF THE DECEASED; THE COURT FINDS THAT SAID ESTATE IS FULLY SOLVENT, AND THAT NOTICE AS REQUIRED BY LAW HAS BEEN GIVEN TO THE DEPARTMENT OF TAXATION AND EXAMINATION CONCERNING THE SETTLEMENT OF THE INHERITANCE TAX DUE THE STATE OF WASHINGTON.
