4. I DESIRE THAT LETTERS TESTAMENTARY OR OF ADMINISTRATION BE NOT REQUIRED OF MY EXECUTRIX; THAT SHE BE RELIEVED FROM THE INTERVENTION OF THE COURTS, EXCEPT TO ADMIT THIS WILL TO PROBATE AND THE FILING OF AN INVENTORY OF MY ESTATE IN THE MANNER REQUIRED BY EXISTING LAWS. I HEREBY GIVE UNTO MY EXECUTRIX FULL POWER AND AUTHORITY TO CARRY OUT THE TERMS AND PROVISIONS OF THIS WILL, ACCORDING TO HER OWN JUDGMENT; AND TO THAT END I HEREBY AUTHORIZE HER TO MAKE SALE OF ANY OF MY PROPERTY, REAL AND PERSONAL, AND GIVE PROPER DEEDS AND CONVEYANCES THEREFOR; TO COLLECT ALL MONEYS DUE ME OR MY ESTATE; TO GIVE RELEASES OF MORTGAGES AND RECEIPTS; TO COLLECT AND RECEIPT FOR ALL MONEYS IN ANY BANK BELONGING TO ME; AND IN FACT TO DO ANY AND ALL NECESSARY ACTS AND THINGS WITHOUT AN ORDER OF THE COURT BEING REQUIRED, NECESSARY IN HER JUDGMENT TO DO TO SETTLE MY ESTATE AND DISPOSE OF IT AS SHE SEES FIT; I THEREFORE DECLARE THIS TO BE A NON-INTERVENTION WILL.
