Know all Men by These Presents; That Spencer Biddle, in consideration of the sum of one dollar and for the purpose of correcting description in release dated September 21, 1931 recorded at page 129 Book T of Mortgage records of Skamania County Washington, does hereby release and discharge from the terms of that certain mortgage dated the 23rd day of October 1928 and recorded on the 26th day of October 1928 at page 332 Book "S" of Mortgages, and re-recorded on November 3rd 1928 in Book "S" of Mortgages page 337, records of Skamania County Washington, wherein Beacon Lake Corporation, a Washington corporation, is mortgagor and Spencer Biddle is mortgagee, the following described real property therein mortgaged, to-wit;

Commencing at a point 700 feet south and 360 feet west of the one-quarter corner on the east line of section 26 tp 2 N of Range 6 East of W. M., which said point is on the west boundary line of State Highway No 8 where there is a post of fir 3 inches in diameter marked "S" bearing from a fir tree 8 inches in diameter northeast from said post also marked "S", thence from said post in a southerly direction along the westerly line of said State Road No 8 a distance of 50 feet, thence N 74° W a distance of 300 feet, thence N 16° E 50 feet, thence N 74° W 257 feet, thence N 16° E a distance of 350 feet more or less to the southerly boundary line of the Kuffler road, thence in an easterly direction along the southerly line of said Kuffler road to intersection with the westerly line of said State Road No. 8, thence along the said State Highway to the point of beginning.

To the intent and purpose that the above described real estate shall be released and discharged from the lien of said mortgage, but that the remainder of the property therein described shall remain subject to the terms and conditions thereof as heretofore.
