

Boulevard and Charleston Street, as established on March 21, 1931; thence north $34^{\circ} 58'$ east 520 feet; thence north $55^{\circ} 2'$ west 400 feet; thence south $34^{\circ} 58'$ west 531.6 feet to a point in the center line of said Swift Boulevard; thence easterly along said center line of said Swift Boulevard 400.2 feet to the point of beginning, excepting therefrom that portion of said property lying within the boundaries of said Swift Boulevard.

(17) Lots 14 and 16 of Block 12, Multnomah Addition.

(18) Lots 1 and 2 of Block 19, East Creston Addition.

(19) That certain tract of land bounded and described as: beginning at the northeast corner of the intersection of S. E. Harold Street and S. E. 41st Avenue, as shown by the official plats of the City of Portland on August 8, 1939; thence north along the east line of said 41st Avenue 125.75 feet; thence east parallel with and 125.75 feet north of the north line of said Harold Street 200 feet; thence south parallel with the east line of said 41st Avenue 125.75 feet to a point in the north line of said Harold Street; thence west along said north line of said Harold Street to the point of beginning.

SEVENTH: The following described property situate, lying, and being in Klickitat and Skamania Counties, in the State of Washington, being unimproved land heretofore acquired by the Company for purposes of future development, namely:

(1) The East half of the southeast quarter, the northwest quarter of the southeast quarter, and the southeast quarter of the northeast quarter of Section 4, Township 3 North, Range 10 East of Willamette Meridian, in said Skamania County.

(2) That certain tract of land in Section 24, Township 5 North, Range 10 East of Willamette Meridian, in said Klickitat County, bounded and described as: beginning at the southwest corner of said section; thence north along the section line common to Sections 23 and 24 in said township and range to the northwest corner of the southwest quarter of the southwest quarter of said Section 24; thence east along the north line of said southwest quarter of southwest quarter to a point in the center line of the White Salmon River; thence southerly following the center line of said river to a point in the south line of said Section 24; thence westerly along the south line of said section to the point of beginning.

(3) That certain tract of land in Section 25, Township 5 North, Range 10 East of Willamette Meridian, in said Klickitat County, bounded and described as: beginning at the northwest corner of said section; thence easterly along the north line of said section to a point in the center line of the White Salmon River; thence southerly along the center line of said river to a point in the west line of said section; thence northerly along the west line of said section to the point of beginning.

(4) The west half of the southwest quarter of Section 20, Township 6 North, Range 11 East of Willamette Meridian, in said Klickitat County.

(5) Those certain tracts or parcels of land in Section 25, Township 3 North, Range 12 East of Willamette Meridian, in said Klickitat County, described as follows:

(a) That part of the northeast quarter of the northwest quarter of said section, bounded and described as: beginning at a point in the east line of said northeast quarter of the northwest quarter, which point is in the northerly line of the right of way owned and occupied by the Spokane, Portland and Seattle Railway Company; thence southwesterly and along the northerly line of said right of way to a point in the south line of said northeast quarter of northwest quarter; thence west along said south line to a point in said line which is 50 feet distant from and measured at right angles to the northerly line of said right of way; thence northwesterly 50 feet along a line which is at right angles to said right of way and passes through said point; thence northeasterly along a line parallel with and 50 feet distant from the northerly right of way line of said railroad to a point in the east line of said northeast quarter of northwest quarter; thence southerly along said east line to the point of beginning.

(b) The south half of the northwest quarter, the north half of the southwest quarter, and the southwest quarter of the northeast quarter, excepting therefrom the right of way of the Spokane, Portland and Seattle Railway Company.

(c) All that part of the northwest quarter of the northeast quarter of said section conveyed to Northwestern Electric Company by Sheriff's deed dated March 26, 1921, and recorded in the deed records of Klickitat County in Book 52D at page 593.

(6) Those certain tracts or parcels of land in Section 26, Township 3 North, Range 12 East of Willamette Meridian, in said Klickitat County, described as:

(a) The southeast quarter of the southwest quarter.

(b) That certain tract of land bounded and described as: beginning at a point in the east line of said section, which point is 922 feet north of the quarter corner common to Sections 25 and 26 in said township and range; thence southwesterly 990 feet to a point in the east and west center line of said section 26 which point is 360 feet west of said quarter corner; thence south $18^{\circ} 30'$ west 1115 feet, more or less, to a point in the westerly line of the
