KNOW ALL MEN BY THESE PRESENTS, THAT MYRTLE ATTWELL AND J. W. ATTWELL, HER HUSBAND, J. W. BETHEA AND HAZEL E. BETHEA, HIS WIFE AND S. M. BARNARD LUMBER COMPANY, A CORPORATION, IN CONSIDERATION OF THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF THREE HUNDRED & TEN DOLLARS, IN HAND PAID, RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE OF WASHINGTON THE FOLLOWING DESCRIBED PARCEL OF LAND SITUATED IN SKAMANIA COUNTY, WASHINGTON, TO-WIT:

A STRIP OF LAND 100 FEET WIDE, BEING 50 FEET ON EACH SIDE OF THE CENTER LINE OF SAID ROAD AS SURVEYED OVER AND ACROSS THE FOLLOWING:

BEGINNING AT THE NORTHEAST CORNER OF THE ELIZABETH SNOOKS D.L.C. WHICH INITIAL POINT IS ALSO THE SOUTHEAST CORNER OF LOT 13 SEC. 25 TP. 2 N. R. 6 E. W.M., RUNNING THENCE SOUTH 89° 56' WEST 554 FEET, THENCE SOUTH 42° 43' EAST TO A POINT ON THE NORTH LINE OF THE PRESENT NORTH BANK HIGHWAY, THENCE FOLLOWING THE NORTH LINE OF SAID HIGHWAY IN A NORTHEASTERLY DIRECTION TO INTERSECTION WITH THE NORTH LINE OF SECTION 30 TP. 2 N. R. 7 E. W.M., THENCE WEST ALONG THE NORTH LINE OF SEC. 30 TP. 2 N. R. 7 E. W.M., AND THE NORTH LINE OF SEC. 25 TP. 2 N. R. 6 E. W.M. TO THE NORTHWEST CORNER OF THE HARDY D.L.C.
