- (9) The southwest quarter of the northeast quarter, the southeast quarter of the southwest quarter, and the northwest quarter of the southeast quarter of Section 18, Township 3 North, Range 13 East of Willamette Meridian, in said Klickitat County, excepting therefrom the right of way of the Spokane, Portland and Seattle Railway Company.
- (10) Those certain tracts or parcels of land in Section 19, Township 3 North, Range 13 East of Willamette Meridian, in said Klickitat County, described as:
 - (a) That part of the northwest quarter of the south west quarter which lies's south of the southerly line of the right of way of the Spokane, Portland and Seattle Railway Company.
 - (b) Government Lot 4, and the southeast quarter of the southwest quarter.
- (11) All that part of the south half of the southeast quarter of Section 24, Township 3 North, Range 12 East of Willamette Meridian, in said Klickitat County, conveyed to Northwestern Electric Company by Sheriff's deed dated March 26, 1921, and recorded in the deed records of Klickitat County in Book 52D at page 593.

EICHTH: The electric transmission lines of the Company situate, lying and being in the States of Washington and Oregon, and extending as follows:

- (1) Beginning at the Lincoln generating station of the Company located upon the tract of land in the City of Portland described in the foregoing division Fourth; thence easterly and northerly, crossing over the Willamette River, and extending to the Albina substation of the Company located upon a part of Block 83, Albina, in said city.
- (2) Beginning at a point on the transmission line referred to in the foregoing subdivision (1), and connecting said transmission line with the electric transmission system of Portland General Electric Company at the latter's generating station known as Station L, located on the east bank of the Willamette River in said City of Portland.
- (3) Beginning at said Albina substation of the Company referred to in the foregoing subdivision (1); thence northerly through the City of Portland and adjacent territory in said Multnomah County; thence crossing the Columbia River by submarine cable and extending to the electric switching station of Pacific Power & Light Company, located upon a part of the northeast quarter of the southeast quarter of Section 20, Township 2 North, Range 1 East of Willamette Meridian, in Clark County, Washington.
- (4) Beginning at a point on the transmission line referred to in the foregoing subdivision (3), and connecting said transmission line with the Knott substation of the Portland General Electric Company on N. E. Knott Street at Rodney Avenue in said City of Portland.
- (5) Beginning at said switching station of Pacific Power & Light Company referred to in the foregoing subdivision (3); thence easterly to the Vancouver substation of Northwestern Electric Company, located apon its property in the City of Vancouver, in said Clark County, described in subdivision (1) of the foregoing division Third.
- (6) Beginning at said Vancouver substation of the Company referred to in the foregoing subdivision (5); thence in an easterly direction to the Camas substation of the
