ALL HER RIGHTS, TITLE AND INTEREST IN AND TO ALL THAT PARCEL OF REAL ESTATE SITUATE IN  
COUNTY OF SKAMANIA STATE OF WASHINGTON, TO-WIT:

KNOWN AND DESCRIBED AS TIDE AND SHORE LAND OF THE SECOND CLASS, SITUATE IN  
SKAMANIA COUNTY, STATE OF WASHINGTON,

BEGINNING AT THE MEANDER CORNER TO FRACTIONAL SECTIONS THREE (3) AND THIRTY-
