HENRIETTA THOMAS ET AL TO PLUMA H. MACKEY

KNOW ALL MEN BY THESE PRESENTS THAT, WHEREAS, ON OR ABOUT THE 25TH DAY OF JUNE 1883 WILLIAM THOMAS AND HENRIETTA THOMAS ENTERED INTO AN AGREEMENT WITH ONE HENRY WICKS FOR THE CONVEYANCE OF TWO ACRES OF LAND MORE OR LESS TO COVER THE IMPROVEMENTS MADE BY THE SAID HENRY WICKS SITUATED ON THE HILL BY ERROR DESCRIBED AS BEING IN LOT 1 SECTION 6 TOWNSHIP 1 NORTH OF RANGE 6 EAST OF W.M., WHICH SAID CONTRACT IS RECORDED AT PAGE 340 BOOK "C" OF DEEDS AND MORTGAGES, RECORDS OF SKAMANIA COUNTY, WASHINGTON; AND,

WHEREAS, THE SISTERS OF CHARITY OF PROVIDENCE ST. VINCENT'S HOSPITAL SUCCEEDED TO THE INTEREST OF THE SAID HENRY WICKS IN AND TO THE PROPERTY THEREIN MENTIONED AND BY A DEED DATED MARCH 25, 1887 AND RECORDED AT PAGE 536 BOOK "D" OF DEEDS DID CONVEY TO PLUMA H. MACKEY THE FOLLOWING DESCRIBED PROPERTY, TO-WIT:

BEING A PART OF LOT 1 OF SEC. 6 TP. 1 NORTH OF RANGE 6 EAST OF W.M. BOUNDED AS FOLLOWS: COMMENCING AT A STONE IN THE CASCADE COUNTY ROAD AND RUNNING S. 15° EAST 3 CHAINS 50 LINKS, THENCE S. 31° WEST 3 CHAINS 50 LINKS, THENCE SOUTH 75° WEST 3 CHAINS 17½ LINKS, THENCE NORTH 15° WEST 3 CHAINS 50 LINKS, THENCE NORTH 75° EAST 3 CHAINS 17½ LINKS, THENCE NORTH 31° EAST 3 CHAINS 50 LINKS TO STARTING POINT CONTAINING 2 ACRES AND 25 SQUARE LINKS.

THAT THE SAID PROPERTY IS DESCRIBED THEREIN AS BEING SITUATED IN LOT 1 SECTION 6 TOWNSHIP 1 NORTH OF RANGE 6 EAST OF W.M., AND WHEREAS, IN TRUTH AND FACT THE PROPERTY INTENDED TO BE CONVEYED BY THE ABOVE MENTIONED INSTRUMENT IS SITUATED IN LOTS 2 AND 3 OF SECTION 6 TOWNSHIP 1 NORTH OF RANGE 6 EAST OF W.M.
