Tract No. O. K. 7: Lots numbered Four (4), Five (5), Six (6), Seven (7), Eight (8), and Nine (9), of Block numbered One Hundred and Forty-eight (148) of the Town (now City) of Astoria, as laid out and recorded by John M. Shively, and later established by Decree of the Circuit Court of the State of Oregon for Clatsop County. K. 8: All of Block numbered Ninety-five (95) excepting the South Twenty (20) feet of Lots numbered Five (5), Six (6), Seven (7), and Eight (8) thereof, which have been conveyed to The City of Astoria, Oregon, a municipal corporation; for street or highway; subject to the full right of The City of Astoria, Oregon, a municipal corporation, to enter into and upon the North Twenty-Three (23) feet of the South Forty-three (43) feet of said Lots numbered Five (5), Six (6), Seven (7) and Eight (8) aforesaid, and place and maintain thereon such earth or other material as may be necessary to properly slope, support and maintain said street or road at the established grade, forever.
