

Subject to a right-of-way conveyed to Wahkiakum County, a duly organized and existing County within the State of Washington, by deed dated November 20, 1933, recorded December 4, 1933 in Book 7, page 527 thereof, Deed Records of Wahkiakum County, Washington.

Tract No. W. W. 7: The Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) and Lots numbered One (1), Two (2), Three (3), and Four (4) of Section Twenty-four (24), in Township Eight (8) North, Range Five (5) West, Willamette Meridian, containing One Hundred Fifty-eight (158) acres, more or less. Excepting therefrom that part thereof conveyed to State of Washington for road purposes, as shown by deed dated March 5, 1928, recorded March 29, 1928, in Book 6, page 132 thereof, Deed Records of Wahkiakum County, Washington.

Also, the following described tide land of the second and third class, situate in Wahkiakum County, Washington, to-wit: Lot Five (5), opposite and adjoining Lot Four (4) of Section 24, beginning at a point 4.90 chains West and 10.00 chains South from the meander corner between Section 13 and 18, Township 8 North, Ranges 4 and 5 West, Willamette Meridian, thence West 2.60 chains to a point; thence South 64 deg. West 13.91 chains to a point; thence South 1.25 chains to a point; thence North 64 deg. East 16.80 chains to the point of beginning, containing 1.73 acres. Also Lot Six (6), opposite and adjoining Lot Three (3) of Section 24, beginning at a point 20.00 chains West and 16.11 chains South from the meander corner between Sections 13 and 18, Township 8 North, Ranges 4 and 5 West, Willamette Meridian, thence South 64 deg. West 1.09 chains to a point; thence South 61 deg. 30 min. West 5.00 chains to a point; thence South 27 deg. West 2.00 chains to a point; thence South 3.50 chains to a point; thence North 10 deg. East 3.10 chains to a point; thence North 37 deg. East 1.60 chains to a point; thence North 61 deg. 45 min. East 5.43 chains to a point; thence North 1.25 chains to the point of beginning, containing .90 acres. Also, Lot Seven (7) opposite and adjoining Lot Two (2) of Section 24, Beginning at a point 7.00 chains South and 19.40 chains East of the one-fourth section corner between Sections 23 and 24, Township 8 North, Range 5 West, Willamette Meridian; thence North 57 deg. 30 min. East 12.00 chains to a point; thence South 70 deg. West 6.00 chains to a point; thence South 81 deg. West 1.70 chains to a point; thence South 33 deg. 30 min. West 5.00 chains to the point of beginning, containing 1.11 acres. Also, Lot Eight (8), opposite and adjoining Lot One (1) of Section 24, beginning at the meander post between Sections 23 and 24, Township 8 North, Range 5 West, Willamette Meridian, thence South 1.80 chains to a point; thence North 47 deg. East 6.00 chains to a point; thence South 62 deg. 30 min. West 5.00 chains to the point of beginning, containing .40 acres, and altogether containing 4.14 acres, more or less, according to the survey thereof, as shown by the official plat of same in the office of the Auditor of Wahkiakum County, State of Washington.

Tract No. W. W. 8: The Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Eighteen (18), in Township Eight (8) North of Range Four (4) West, of the Willamette Meridian, containing Thirty-one (31) acres, more or less.

Tract No. W. W. 9: That certain tract or piece of land which may be described as follows: Commencing at a stake set in a mound of stones on the Northerly bank of the Columbia River at a point Five Hundred (500) feet Southwesterly from the Dock and buildings of Wm. Hume, and running thence North to the North line of Lot Three (3), hereinafter mentioned; thence West to the West line of Lot Four (4) (or a prolongation thereof) hereafter mentioned; thence South to the low water mark on the Columbia River and thence Easterly along said river to the point of beginning, being a portion of Lot Three (3) and the whole of Lot Four (4) of Section Eighteen (18), in Township Eight (8) North, Range Four (4) West, of the Willamette Meridian, containing Eighty (80) acres, more or less. Excepting therefrom that part thereof conveyed to State of Washington for road purposes, as shown by deed dated March 5, 1928, recorded March 29, 1928 in Book 6, page 132 thereof, Deed of Records of Wahkiakum County, Washington.

Tract No. W. W. 10: All that portion of Lots One (1), Two (2) and Three (3), of Section Nine (9), in Township Eight (8) North of Range Six (6) West, Willamette Meridian, lying West of the Western boundary line of that certain Dike commonly called "Brown's Dike" of Dike No. Three of Wahkiakum County, Washington, excepting such of said above described Lot No. One (1) as may be included in that certain Five (5) acres conveyed to Mary Ann Taylor by John Ostervold, and Fanny Ostervold, his wife, May 9th, 1895, which deed is recorded in Vol. "F" of the Record of Deeds of Wahkiakum County, at pages 515 and 516;

Also all tidelands of the third class, situate in front of, abutting upon and adjacent to all of Lots One (1), Two (2), Three (3) and Four (4), Section Nine (9), Township 8 North, Range 6 West of the Willamette Meridian; the meander line of said Lots bordering on said tidelands being more particularly described according to the United States Government field notes as follows, to-wit: Beginning at the meander corner to fractional Sections 4 and 9 said township and range, which is 24.20 chains West of the corner to Sections 3, 4, 9 and 10, thence along the meander line in front of said lots 1, 2, 3 and 4; thence South 10 deg. West 15 chains; thence South 5 deg. West 16.50 chains; South 49.00 chains to the meander corner to fractional sections 9 and 16, which is 28.19 chains West of the corner to Sections 9 and 10, 15 and 16, aforesaid township and range, having a total frontage of 80.50 lineal chains on the meander line of said Lots 1, 2, 3 and 4 as shown by said Government field notes and the plat of same on file in the office of the Board of State Land Commissioners at Olympia, Washington;

Also, all tidelands of the second class, lying between the line of mean low tide and the line of extreme low tide and in front of Lots 1, 2, 3 and 4, Section 9, Township 8 North, Range 6 West of the Willamette Meridian, with a frontage of 80.50 lineal chains, more or less, measured along the meander line, according to a certified copy of the Government field notes of the Survey there-
