All those certain premises known as the Jim Crow Sands or seining grounds, being certain tide flats now owned by the said above mentioned lessors as successors in interest to Frank Cook and W. L. Enyart and which tide flats are located in the Columbia River in Sections Twenty-one (21) and Twenty-two (22) Township Nine (9) North Range Seven (7) West W. M. in the County of Clatsop, State of Oregon, it being the intention of said lessors to lease, demise and let to the said lessees the tide lands owned by them as aforesaid in the Columbia River in Clatsop County, State of Oregon, together with all the rights, appurtenances and accretions thereunto belonging or appertaining;

which said lease was modified by a certain addenda attached thereto and by its terms was made a part thereof, which addenda was dated January 21, 1935 and was signed by said lessors and also by Jack Matschiner, husband of the said Stella Matschiner, and by said Columbia River Packers Association, Inc. and Barbey Packing Company, and by its terms, it and said original lease dated January 15, 1935 are to be construed together as one lease; which said lease was extended two years by an instrument executed by said lessors dated November 6, 1935.

(g) All of the right, title and interest of said Columbia River Packers Association, Inc. in and to a certain lease dated April 13, 1935 wherein the city of North Bend, a municipal corporation in Coos County, Oregon, leased to said Columbia River Packers Association, Inc. for the term of ten years beginning May 1, 1935 and terminating on April 30, 1945, the following described premises located in said city of North Bend, Coos County, Oregon, to-wit:

All that portion of the municipal wharf which said wharf is located at the foot of Virginia Avenue in the said city of North Bend, together with that portion of the warehouse on said wharf which is North of beginning at a point 64.6 feet North of the Southwest corner of the warehouse on said wharf and thence run East to the center of the warehouse a distance of about 25 feet; thence North a distance of 16 feet along the center line of said warehouse; thence East to the East edge or East side of the warehouse a distance of 16 feet, together with the space and full width of said wharf and for a distance of 40 feet North of the North line of saidwharf;
