IN THE MATTER OF STATE ROAD No. 8 STEVENSON TO WIND RIVER

KNOW ALL MEN BY THESE PRESENTS, THAT SKAMANIA COUNTY A MUNICIPAL CORPORATION OF THE STATE OF WASHINGTON, OF THE COUNTY OF SKAMANIA, IN THE STATE OF WASHINGTON, IN CONSIDERATION OF THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF ONE DOLLARS, IN HAND PAID, RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE OF WASHINGTON THE FOLLOWING DESCRIBED PARCEL OF LAND SITUATED IN SKAMANIA COUNTY, WASHINGTON, TO-WIT:

A STRIP OF LAND 50 FEET WIDE, BEING 50 FEET ON NORTH SIDE OF THE CENTER LINE OF SAID ROAD AS SURVEYED OVER AND ACROSS TAX LOT #5, MORE SPECIFICALLY DIS-
