debts ascertained to be worthless and charged off, or, a reasonable addition to the reserve for bad debts; depreciation, in accordance with the provisions of the State of Oregon corporate excise statute and the rules and regulations of the Oregon State Tax Commission thereunder; and, generally, all of the ordinary and reasonable operating expenses and fixed charges paid or incurred during the year in carrying on the business, including but not limited to, outlays for maintenance, repairs and rentals, and a reasonable allowance for salaries or other compensation for personal services actually rendered. Provided, that in computing the net earnings of the Company for the purpose of determining the obligation of the Company to pay interest on these debentures, any payments of interest on the debentures for the previous year shall not be taken into consideration.

Section 7. This trust deed need not be recorded at any time with any federal or state official for the purpose of evidencing the lien on the trade marks and brands.
