whereas, on the 20th day of May, 1925, P. A. Peterson and Pauline C. Peterson, husband and wife, made, executed and delivered to GEORGE M. SCAMMON and PEARL M. SCAMMON, husband and wife, their promissory note for Seven Thousand Five Hundred Dollars (\$7500.00), bearing the date of the 20th day of May, 1925, the said note being payable on the 20th day of May, 1930, with interest at the rate of six per cent (6%) per annum, payable annually; and

WHEREAS, For the purpose of securing the said note the said P. A. PETERSON and PAULINE C. PETERSON, husband and wife, made, executed and delivered to the said GEORGE M. SCAMMON and PEARL M. SCAMMON, husband and wife, a mortgage on the following described real property:

Beginning at the quarter corner on north line of Section 22, being the northeast corner of Lot 2; thence south 660 feet; thence west 660 feet; thence south 540 feet to the north boundary of the State Highway right of way; thence westerly along said boundary to a point 40 feet west of the west line of Lot 2; thence north to a point 40 feet west of the northwest corner of Lot 2; thence east along north line of Section 22, 1360 feet to the northwest corner of Lot 2 to the place of beginning, containing 30 acres, more or less, all in Tp. 2 N. R. 7 east of W.M.

Also a perpetual right of way for and the right to lay a line of pipe not to exceed six inches in diameter by the most practical and shortest route over and across lands of the grantor to a certain spring located 306 feet south, more or less, of the northeast corner of the northwest quarter of southwest quarter of Section 15 Tp. 2 N. R. 7 east of W. M., with perpetual right of ingress and egress for laying, repairing and maintaining said pipe line, and the right to do such necessary work or improvement as may be necessary at the spring for the successful taking of the water therefrom by means of said pipe line.

R. 7 east of W. M.
