NOW, THEREFORE, THIS INDENTURE WITNESSETH that The Chase National Bank of the City of New York and Carl E. Buckley, as Trustees as aforesaid, hereby certify and acknowledge that the Mortgage has been paid, satisfied and discharged in full and do hereby remise, release and quitclaim unto the Company, its successors and assigns forever, all their right, title and interest as Trustees under the Mortgage in and to all the property subject to the lien thereof.
