PETITION FOR PROBATE OF WILL.

TO THE JUDGE OF THE SUPERIOR COURT OF THE STATE OF WASHINGTON FOR CLARKE COUNTY:
COMES NOW ELLA T. NOBLE, THE WIDOW OF H. E. NOBLE, DECEASED, AND PETITIONS THE COURT
AND RESPECTFULLY SHOWS:

THAT H. E. NOBLE DIED ON THE 17TH DAY OF JANUARY, 1926, IN THE CITY OF PORTLAND, OREGON, AND SAID DECEASED, AT THE TIME OF HIS DEATH AND FOR A NUMBER OF YEARS PRIOR THERETO, WAS A RESIDENT AND INHABITANT OF THE CITY OF PORTLAND, MULTNOMAH COUNTY, OREGON, AND HE NEVER WAS AT ANY TIME A RESIDENT OR INHABITANT OF THE STATE OF WASHINGTON, OR OF ANY OTHER COMMUNITY STATE AND SAID DECEASED LEFT AN ASTATE IN THE STATE OF WASHINGTON AND IN CLARKE COUNTY WHICH REQUIRES PROBATE;

THAT THE APPROXIMATE VALUE OF THE PERSONAL PROPERTY BELONGING TO SAID ESTATE IN THE STATE OF WASHINGTON, AS NEAR AS YOUR PETITIONER IS ABLE TO ALLEGE IS OF THE SUM OF FOUR THOUSAND (\$4000.00) DOLLARS AND THE ANNUAL INCOME FROM THE REAL ESTATE BELONGING TO SAID ESTATE IS APPROXIMATELY SEVEN HUNDRED SIXTY TWO (\$762.00) DOLLARS PER ANNUM;
