I, HENRY E. NOBLE, HEREBY MAKE AND PUBLISH THIS CODICIL TO MY LAST WILL OF DATE DECEMBER 24, 1923, CONFIRMING SAID WILL IN ALL RESPECTS SAVE FOR THE LEGACY HEREIN GIVEN.

MY GRANDSON HART MINER HAVING RECENTLY BESTOWED UPON ME OUT OF THE FULLNESS OF HIS HEART, TO EXPRESS HIS GRATITUDE AND APPRECIATION FOR A CHRISTMAS PRESENT I HAD MADE TO HIM, THE SUM OF FIFTEEN CENTS OF HIS OWN EARNINGS, AND HAVING ACCOMPANIED THE GIFT WITH THE REMARK THAT HE THOUGHT HE WOULD GIVE ME MONEY BECAUSE I LIKED MONEY SO MUCH, I HEREBY, IN CONSIDERATION BOTH OF THE PENETRATING JUDGMENT OF CHARACTER AND THE WILLING SACRIFICE SHOWN IN SAID GIFT TO ME, DIRECT MY TRUSTEES NAMED IN THE WILL ABOVE REFERRED TO TO PROVIDE FOR MY SAID GRANDSON, IN ADDITION TO THE LEGACY GIVEN HIM IN SAID WILL, A SUM WHICH WOULD RESULT FROM AN INVESTMENT OF SAID FIFTEEN CENTS AS OF THE DATE OF THE LAST BIRTHDAY OF MY GRANDSON PRECEDING THIS DATE, DOUBLED AT HIS NEXT BIRTHDAY, THE RESULTING PRODUCT DOUBLED AT THE NEXT, AND SO ON IN GEOMETRICAL PROGRESSION TO AND INCLUDING HIS TWENTY-FIRST BIRTHDAY WHEN THE AMOUNT (WHICH, MATHEMATICALLY EXPRESSED, WOULD BE THE PRODUCT OF THE FIFTEEN CENTS MULTIPLIED BY TWO RAISED TO THE FIFTEEN<sup>TH</sup> POWER, FIFTEEN BEING THE NUMBER OF HIS BIRTHDAYS BEGINNING WITH THE NEXT AND ENDING WITH THE TWENTY-FIRST) SHALL BE GIVEN IMMEDIATELY TO MY SAID GRANDSON.
