KNOW ALL MEN BY THESE PRESENTS, THAT I, MINNIE M. FOUTS OF THE AGE OF 52 YEARS AND BEING OF SOUND AND DISPOSING MIND AND MEMORY AND NOT ACTING UNDER DURESS, MENACE, FRAUD OR THE UNDUE INFLUENCE OF ANY PERSON WHOMSOEVER, DO MAKE, PUBLISH AND DECLARE THIS TO BE MY LAST WILL AND TESTAMENT IN MANNER FOLLOWING;

1ST. I DIRECT THAT MY BODY BE DECENTLY BURIED WITH PROPER REGARD TO MY STATION AND CONDITION IN LIFE.

2ND. I GIVE AND BEQUEATH TO D. C. FOUTS, TRUSTEE FOR THE BENEFIT OF MY NIECE, MARVEL FOUTS, MY PIANO AND A CERTAIN SMALL DIAMOND, NOW UNSET, AND THE RING FOR THE SAME. IT BEING MY DESIRE THAT MY BROTHER, D. C. FOUTS SHALL DELIVER THE SAME TO MY SAID NIECE AS SOON AS SHE IS OF SUFFICIENT AGE TO USE THE SAME, AND HE SHALL BE AUTHORIZED TO EXECUTE A RECEIPT TO MY EXECUTOR FOR THE PROPERTY HEREINBEFORE BEQUEATHED FOR AND ON BEHALF OF MY SAID NIECE, MARVEL FOUTS.

3RD. I GIVE, DEVISE AND BEQUEATH TO MY SISTER, JESSIE M. FRIEDRICH, AN UNDIVIDED ONE THIRD INTEREST IN AND TO THE SHARES OF STOCK OWNED BY ME IN THE PETROLEUM INDUSTRIAL CORPORATION OF AMERICA, ALL OF LOT ONE (1) BLOCK FIVE (5) AND ALL OF THAT PORTION OF LOT TWO (2) BLOCK FIVE (5) NOT OCCUPIED BY THE GARAGE BUILDING LOCATED ON LOTS TWO (2) AND THREE (3) IN SAID BLOCK FIVE (5) IN THE TOWN OF COOKS, SKAMANIA COUNTY, WASHINGTON.
