FOUTS, DECEASED, AND THAT HE BE APPOINTED EXECUTOR, AND THAT LETTERS TESTAMENTARY BE ISSUED TO HIM, AND IT APPEARING TO THE COURT THAT SAID DECEDENT MINNIE M. FOUTS DIED ON OR ABOUT THE 6 DAY OF APRIL A. D. 1926, IN THE COUNTY OF CLACKAMAS AND STATE OF OREGON, AND THAT AT THE TIME OF HER DEATH WAS A RESIDENT OF THE COUNTY OF CLACKAMAS AND STATE OF OREGON.
