LATREILLE, UNMARRIED, OF LOS ANGELES CALIFORNIA, IN CONSIDERATION OF ONE DOLLAR TO ME PAID BY THOMAS REATH OF SKAMANIA WASHINGTON, RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, HAVE REMISED, RELEASED AND FOREVER QUITCLAIMED, AND BY THESE PRESENTS DO REMISE, RELEASE AND FOREVER QUITCLAIM TO SAID THOMAS REATH, HIS HEIRS AND ASSIGNS ALL MY RIGHT, TITLE AND INTEREST IN AND TO THE FOLLOWING DESCRIBED REAL PROPERTY SITUATE AND BEING IN SKAMANIA COUNTY WASHINGTON TOWIT:

THE NORTH HALF ($\frac{1}{2}$) OF THE NORTH EAST QUARTER ($\frac{1}{4}$), AND THE SOUTH WEST QUARTER OF THE NORTH EAST QUARTER ($\frac{1}{4}$) OF SECTION THIRTY TWO (32) IN THO TOWNSHIP 2 N R 6 E W M.

ALSO COMMENCING AT A POINT WHERE THE WEST BANK OF DUNCAN CREEK INTERSECTS THE NORTHERLY BOUNDARY LINE OF THE NORTH BANK HIGHWAY IN SECTION 34 Tp 2 N R 6 E W M, AND RUNNING THENCE NORTHWESTERLY ALONG THE WEST BANK OF SAID DUNCAN CREEK 100 FEET; THENCE SOUTHWESTERLY PARALLEL WITH THE NORTHERLY BOUNDARY LINE OF SAID HIGHWAY 60 FEET; THENCE SOUTHEASTERLY PARALLEL WITH THE WEST BANK OF SAID DUNCAN CREEK 100 FEET TO THE NORTHERLY BOUNDARY LINE OF SAID HIGHWAY; THENCE NORTHEASTERLY ALONG THE NORTHERLY LINE OF SAID HIGHWAY 60 FEET TO THE PLACE OF BEGINNING.
