I, E. C. AMANN, BEING FIRST DULY SWORN, ON OATH DEPOSE AND SAY: THAT I AM A RESIDENT OF THE CITY OF PRAIRIE DU CHIEN, COUNTY OF CRAWFORD, STATE OF WISCONSIN, AND HAVE BEEN SUCH RESIDENT FOR MORE THAN THIRTY FIVE (35) YEARS LAST PAST; THAT I AM CASHIER OF THE CRAWFORD COUNTY BANK, OF SAID CITY;

THAT THE J. K. LUMBER COMPANY, A WASHINGTON CORPORATION, HERETOFORE, AND ON THE FIRST DAY OF JANUARY, 1913, EXECUTED AND DELIVERED ITS BOND MORTGAGE OR DEED OF TRUST UPON CERTAIN LANDS IN SKAMANIA COUNTY, WASHINGTON, TO CONTINENTAL & COMMERCIAL TRUST & SAVINGS BANK, AN ILLINOIS CORPORATION, AND FRANK H.
