Indenture made this 4th day of March 1941, by and between Bankers Trust Company, a corporation organized under the laws of the State of New York, as Trustee, party of the first part, City Bank Farmers Trust Company, formerly The Farmers' Loan and Trust Company, a corporation organized under the laws of the State of New York, as Trustee, party of the second part, and United States of America, party of the third part.
