This Agreement, made this 10th day of December, 1940, between Joseph L. Brodala and Vera Brodala, husband and wife now and at all times since prior to May 27th, 1939, hereinafter designated as Mortgagors, and the Federal Farm Mortgage Corporation, a corporation existing under the Act of Congress known as the Federal Farm Mortgage Corporation Act, hereinafter designat^{ed}/as Mortgagee, said Mortgagee having a district office in the Twelfth Farm Credit District at the office of The Federal Land Bank of Spokane, Spokane, Washington,

Witnesseth:

That, Whereas, By mortgage recorded in Book T of Mortgages, at page 341, records of Skamania County, State of Washington, Mortgagors, or their predecessors in interest, mortgaged to the Land Bank Commissioner, acting pursuant to Part III of the Emergency Farm Mortgage Act of 1933 and amendments thereto, the real property described therein, reference to which mortgage as so recorded is hereby made for the terms thereof and the description of said property, which mortgage is owned by the said Federal Farm Mortgage Corporation; and
