WILLS; AND THAT THEY WILL, AND THEIR HEIRS, ADMINISTRATORS AND EXECUTORS SHALL FOREVER WARRANT AND DEFEND THE TITLE THERETO AGAINST ALL LAWFUL CLAIMS, EXCEPTING THE EQUITY OF SAID P. S. C. WILLS, AND ANY INCUMBRANCES MADE OR SUFFERED BY HIM (INCLUDING TAXES LEVIED SINCE THE DATE OF THE ABOVE MENTIONED CONTRACT.

AND THE SAID P. S. C. WILLS DOES HEREBY REMISE, RELEASE AND QUITCLAIM UNTO THE SAID PARTY OF THE SECOND PART ALL HIS RIGHT, TITLE AND INTEREST IN AND TO THE SAID PRE-MISES.
