KNOW ALL MEN BY THESE PRESENTS, THAT H. B. McDONALD MARY E. McDONALD AND..... HIS WIFE, OF THE COUNTY OF SKAMANIA, IN THE STATE OF WASHINGTON, IN CONSIDERATION OF THE BENEFITS AND OTHER VALUABLE CONSIDERATIONS, AND THE SUM OF EIGHTY DOLLARS, IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED, AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO THE STATE OF WASHINGTON, THE FOLLOWING DESCRIBED PARCEL OF LAND SITUATED IN SKAMANIA COUNTY, IN THE STATE OF WASHINGTON, TO-WIT:

A STRIP OF LAND 320 FEET WIDE, BEING 200 FEET WIDE ON THE NORTHERLY SIDE AND 120 FEET WIDE ON THE SOUTHERLY SIDE OF THE CENTERLINE OF SAID ROAD AS SURVEYED OVER AND ACROSS THE $NE\frac{1}{4}$ $SE\frac{1}{4}$ SEC. 9, TWP. 1, N. R. 5 E. W. M., EXCEPT AS FOLLOWS:

FROM THE WESTERLY BOUNDARY LINE OF SAID $NE\frac{1}{4}$ OF $SE\frac{1}{4}$ TO STA. 430 PLUS 90.1 SAID STRIP OF LAND SHALL BE 500 FEET WIDE ON THE SOUTHEASTERLY SIDE OF SAID CENTERLINE.

FROM STATION 441 PLUS 00 TO THE NORTHERLY AND EASTERLY BOUNDARY LINE OF SAID $NE\frac{1}{4}$ $SE\frac{1}{4}$ SECTION 9, SAID STRIP OF LAND SHALL BE 600 FEET WIDE ON THE SOUTHEASTERLY SIDE OF SAID CENTERLINE.
