THIS INDENTURE WITNESSETH, THAT KATIE WALTHER, SINGLE, RESIDING AT UNDERWOOD, SKAMANIA COUNTY, STATE OF WASHINGTON, PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE (\$1,00) DOLLARS, IN LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HER IN HAND PAID BY MARY WALTHER (MRS. CHARLES WALTHER) PARTY OF THE SECOND PART, HAS GRANTED, BARGAINED AND SOLD, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTY OF THE SECOND PART, AND TO HER HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY, SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT;

BEGINNING AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 15, IN TOWNSHIP 3, NORTH OF RANGE 110, EAST OF WILLAMETTE MERIDIAN, RUNNING THENCE NORTH 40 RODS; THENCE EAST 40 RODS; THENCE NORTH 40 RODS TO THE MIDDLE OF SECTION LINE; THENCE EAST ON SAID LINE, 31 RODS TO LAND KNOWN AS THE S.C.
