THE EAST HALF OF THE SOUTHEAST QUARTER, THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER, SECTION 7, TOWNSHIP 1, NORTH OF RANGE 5 EAST OF THE WILLAMETTE MERIDIAN, CONTAINING 120 ACRES, MORE OR LESS; EXCEPTING A STRIP 18 RODS WIDE AND 90 RODS LONG ALONG THE SOUTH SIDE OF THE WEST HALF OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 8, TOWNSHIP 1 NORTH OF RANGE 5 EAST OF THE WILLAMETTE MERIDIAN DEEDED TO B.
