F. RIDENOUR AND ADA S. RIDENOUR, HIS WIFE, J. P. GREINIA ACTING FOR HIMSELF AND AS ADMINISTRATOR OF THE ESTATE OF ELLA M. GREINIA, DECEASED, KATHRYN J. EASTHAM AND OTHERS, AND THE STATE OF WASHINGTON.
